

Activities of the International Committee of the Red Cross (ICRC) in Iran

We provided **face to face** awareness raising on **risks of mines and Explosive Remnants of War (ERW)** to more than **5,000** residents of the western provinces.



We distributed **hygiene items including masks and sanitizers** as well as **training brochures** among **27,000** of residents of these provinces who were at risk of mines and ERWs and COVID pandemic.

We provided **in-person** Mine Risk Education (MRE) to more than **210,000** Afghan migrants returning to their country at the boarder of Iran and Afghanistan in northeast of the country.



We distributed **123,500 hygiene packages including masks and sanitizers** as well as **training leaflets on mine risk, COVID pandemic and prevention of family members separation on migratory routes** among these people.

Approximately **2 million people** visited our MRE training products or messages on cyberspace.



Similar to the previous years, we were present and provided support during hand-over ceremony of **192 sets of human remains of Iranian soldiers** from Iran-Iraq war.

We reunited **107 families** who had lost their contact with their loved ones during migratory routes in Europe and other continents.



We donated **DNA extraction, amplification and DNA sequencing analysis kits** to Iranian Legal Medicine Organization in the aftermath of the **Ukrainian plane incident** to help identification of the **176 victims** of this incident.

We provided **20,000 free medical and nutrition consultations** to vulnerable Afghan migrants residing in the suburban areas of Mashhad. Also, we distributed **50,000 sets of PPE items** amongst them.



We donated an amount equal to **1,000,000 CHF** to support the IRCS response to COVID-19 pandemic. This amount was spent on purchasing Personal Protective Equipment (PPE), sanitizers, and food items, and **400 oxygen concentrators**.

We provided **physical rehabilitation services**, as well **hygiene kits and PPE items**, to **4,745 vulnerable residents** in Iranshahr, Zahedan, Zabol and Chabahr.



We organized **free training sessions on women's health and nutrition** for **46,690 migrants**.

We promoted and disseminated the **International Humanitarian Law (IHL)** and humanitarian principles.



We purchased and transported **67 shipments** of relief and humanitarian items worth around **70 billion IRR** to **Iraq, Syria, Afghanistan, Pakistan, Armenia, and Azerbaijan**.

We continued **dialogue and exchanging opinion** with Iranian authorities on **humanitarian situation** in countries of the region.
